Mr Registrar LUNG was admitted as Solicitor in Hong Kong and the Supreme Court of England in 1984 and 1988 respectively.

He was admitted as Barrister of the Federal Court of High Court of Australia in 1988 and Barrister and Solicitor of the Supreme Court of Australian Territory Capital in the same year.

He was later admitted Advocate and Solicitor of the Supreme Court of Singapore in 1990. Mr LUNG was in private practice between 1984 and 1990.

He joined the Hong Kong Judiciary as Magistrate in 1990 and was appointed as Principal Presiding Officer of the Labour Tribunal in 1997. He was appointed as Deputy Registrars of the High Court in 2000.
